1. Introduction

The Bohol Health Club (“BHC”, “the Club”, “we”, “us”) is a private members health and performance facility located in Bohol, Philippines.

Membership is limited and subject to approval. The Club is not open to the general public.

By applying for or holding membership, you agree to these Terms & Conditions.

2. Membership Structure

- Membership is capped at 30 individuals.
- All applications are reviewed personally.
- Approval is at the sole discretion of management.
- Membership is non-transferable.
- The Club reserves the right to decline or revoke membership at its discretion.

3. Membership Duration & Commitment

Standard memberships are offered on a minimum 3-month basis.

Shorter-term memberships may be approved at management discretion.

Founding member rates apply only until allocated capacity is filled. Standard pricing applies thereafter.

4. Fees & Payment

- Membership fees are payable monthly in advance.
- Fees are non-refundable once a billing period has commenced.
- The Club reserves the right to adjust pricing for future memberships.
- Late payments may result in suspension of access.

5. Conduct & Environment

The Bohol Health Club operates as a private, disciplined training environment.

Members agree to:

- Conduct themselves respectfully
- Maintain discretion regarding other members
- Refrain from unauthorised filming or recording
- Follow facility guidelines and staff instructions

The Club reserves the right to revoke membership for behaviour inconsistent with the environment or standards of the Club.

6. Health & Physical Activity Disclaimer

By participating, members acknowledge:

- They are voluntarily engaging in physical activity.
